With this awareness, we are committed to processing and safeguarding all kinds of your personal data in the best possible way and with utmost care. We process your personal data within the framework described below as the Data Controller under the Personal Data Protection Law No. 6698 (hereinafter referred to as the Law) and relevant legislation.

Within the scope of the Law, data processing refers to all kinds of operations carried out on data, whether wholly or partly automated or non-automated, including obtaining, recording, storing, updating, classifying, sharing with third parties permitted by legislation, or transferring data to them, provided that they are part of any data recording system.

### **COLLECTION, PROCESSING, AND PURPOSES OF PROCESSING PERSONAL DATA**

To provide you with high-quality services, we process your personal data based on the nature of the service provided; within the framework of the following purposes: Offering the products and services provided by the Company within the determined legal framework, Fulfilling the contractual and legal obligations of our Company completely and accurately, Carrying out the necessary studies by our business units to benefit you from the products and services offered by our Company, Ensuring the execution of the human resources policies of our Company and within the personal data processing conditions and purposes specified in Articles 5 and 6 of the Personal Data Protection Law, your personal data may be processed through the website.

In this context, within the framework of all activities carried out by our company and for the purpose mentioned above, your personal data and your special categories of personal data obtained may be processed within the framework of the personal data processing conditions and purposes specified in Articles 5 and 6 of the Law as stated below.

### **TRANSFER OF PERSONAL DATA**

Your personal data may be shared with our business partners, suppliers, Company officials, shareholders, legally authorized public institutions, judicial authorities, our lawyers, tax consultants, and auditors, including third parties we consult, within the framework of personal data processing conditions and purposes specified in Articles 8 and 9 of the Personal Data Protection Law and other relevant legislation.

### **METHOD AND LEGAL BASIS OF PERSONAL DATA COLLECTION**

Your personal data are collected and processed through all kinds of verbal, written, visual, or electronic media within the legal framework of all kinds of work included in CENK SHIPPING's field of activity to perform the contractual and legal obligations of CENK SHIPPING in full and accurately, and in this context, the legal basis for collecting your personal data is primarily the Personal Data Protection Law No. 6698 and other relevant legislation.

### **YOUR RIGHTS REGARDING THE PROTECTION OF PERSONAL DATA**

In accordance with the Law and relevant regulations;

- You have the right to learn whether your personal data is processed,
- If your personal data has been processed, you have the right to request information regarding this,
- You have the right to access and request these data if your personal health data have been processed,
- You have the right to learn the purpose of processing your personal data and whether they are used appropriately for their purpose,
- You have the right to know the third parties to whom your personal data are transferred within or outside the country,
- If your personal data are incomplete or incorrectly processed, you have the right to request their correction,
- You have the right to request the deletion or destruction of your personal data,
- You have the right to request the correction and/or deletion of your personal data and to request the notification of these transactions to third parties to whom your personal data have been transferred,
- You have the right to object to the occurrence of a result against you by the analysis of the processed data solely through automated systems,
- If your personal data are processed unlawfully, you have the right to demand the compensation of damages.

### DATA SECURITY AND RIGHT TO APPLY

Your personal data are meticulously protected within technical and administrative possibilities, and necessary security measures are provided at an appropriate level according to possible risks, taking into account technological possibilities. In accordance with Article 13 of the Personal Data Protection Law, you can submit your request to use the aforementioned rights to our Company in writing or through other methods determined by the Personal Data Protection Board. Our company will conclude your request, free of charge, as soon as possible and within a maximum of thirty (30) days, depending on the nature of the request. However, if the transaction requires an additional cost, a fee will be charged according to the tariff determined by the Personal Data Protection Board.
